

# LEGAL AID AND THE COVID-19 CRISIS



When the COVID-19 crisis hit Western New York, the Legal Aid Bureau of Buffalo mobilized quickly to help our indigent population. Economically disadvantaged people are disproportionately affected by the faltering economy, skyrocketing unemployment, housing insecurity, and other threats to people's health, safety, and stability. We expect the COVID-19 pandemic to cause a significant increase in the number of people who are eligible for services, with record numbers of people losing full-time, part-time, and gig-economy jobs.

The Legal Aid Bureau is committed to continuing to serve our clients. We are taking precautions to protect the health and safety of our staff, clients, volunteers and all community members in response to uncertainty around the spread of COVID-19. While we are not availabe in-person at this time, we continue to provide all of our services. With budget cuts looming and demand for legal aid increasing, we need your support now more than ever. ## WHAT LEGAL AID IS DOING TO HELP DURING COVID-19

#### CRIMINAL DEFENSE PRACTICE

The Legal Aid Bureau of Buffalo's Criminal Defense Unit continues to operate, albeit largely remotely, during the coronavirus crisis. All Erie County Criminal matters, including arraignments, are being held in one "virtual part." Our attorneys are appearing daily in that courtroom via Skype. All attorneys are available to consult by phone or e-mail on their cases. They are actively reviewing files and reaching out to clients for case reviews and consolations. Our phones, voicemails and e-mails are being monitored daily. If you have questions regarding an ongoing criminal matter or for other issues such as bail motions, order of protection modifications, or questions regarding court return dates, please contact us at any time at 716-853-9555.

#### APPEALS AND POST-CONVICTION PRACTICE

During this tenuous time, the Appeals and Post-Conviction Unit continues to correspond with their clients and perfect appeals. Although the Appellate Division, Fourth Department briefly suspended the complete filing of briefs, we remained determined to continue preparing briefs and appendices for filing in order to prevent any further delay when the court officially reopened. We also continue to discuss our clients' cases with them via confidential telephone calls. The Court of Appeals is accepting leave applications and we are preparing and filing them for our clients.

The Legal Aid Bureau <u>signed a letter to the Governor on our clients' behalf requesting release of individuals incarcerated in state prisons</u> during this unprecedented health crisis. <u>The letter was dated April 3, 2020</u>. We are also working with other agencies to advocate for the release of medically vulnerable prisoners throughout the state.

#### ATTORNEYS FOR CHILDREN PRACTICE

At the Legal Aid Bureau, our Attorneys for Children represents children in child welfare and juvenile justice matters. Every day, our lawyers stand side-by-side with the most vulnerable children and youth in our community, giving them a clear and strong voice in decisions that affect their lives. Now, more than ever, we are concerned about the well-being and safety of children everywhere, and especially the most vulnerable children among us in Erie County.

During this COVID-19 health crisis, our attorneys, social workers and child advocates are working tirelessly to connect with our clients, whether they live with family, in foster care, or in other residential settings. When the Family Court shut down in March for all but "essential" appearances, our attorneys continued to appear in court to represent children. When the court transitioned to "virtual proceedings," we adapted quickly, set up home computers and now appear routinely in Family Court daily, though remotely daily, serving at the court's disposal to represent children in child welfare, juvenile justice and similar matters. Early on in this crisis, aware of risks to children and adults in the transmission of COVID-19, our lawyers secured the safe release of youth held in local detention facilities, returning them home to safety.

#### CIVIL LEGAL SERVICES

All of our attorneys our standing by to respond to inquiries via our hotline numbers below. We continue to offer the full scope of civil legal services, including: assisting low-wage workers with questions about their unemployment insurance applications; aiding tenants facing evictions and foreclosures who are unsure about their rights; helping with debt collection matters; and assisting on family security cases. We accept applications by email (CLS@ legalaidbuffalo.org), by phone at 716-853-9555 Ext. 400, and through our website contact form. Intakes are processed by email, snail mail, and/or fax. Initial consults for new clients are conducted by phone and teleconference.
